



## **Competition Rules:**

### **Addendum: Tomorrowland Competition**

1. In addition to the standard 5FM Competition Terms and Conditions, the below Rules also apply for the Tomorrowland competition conducted by 5FM in conjunction with WeChat Africa Services Pty Ltd (“WAS”), the sponsor of the main prizes.
  - a. **Competition Entry Period:** Entries for the competition open on Friday, 10 June 2016 and close on Friday, 1 July 2016 at 16h00.
  - b. **Who can enter:** The competition is only open to entrants 18 years of age or older, who are South African residents and who hold a passport valid until end January 2017. Also, you may NOT participate if you are a supplier of goods or services in connection with this competition, or if you are a director, member, partner, employee, agent of, or consultant to 5fm, WAS or any other entity directly or indirectly controlling or controlled by 5fm or WAS, or if you are any of the aforementioned persons’ spouse, life partner, parent, child, brother, sister or business partner
  - c. **How to enter:** To enter the competition, contestants must visit 5FM.co.za, scan the QR code on the competition page with their WeChat app and then follow the entry process via WeChat which includes successfully registering for a WeChat wallet (if they do not already have one). People can only enter once in this manner. There are no entry fees for this competition (although note that the entry process may incur data charges by your mobile network operator)
  - d. **Competition phases, winners & prizes:** The competition will consist of three phases:
    - i. *Phase One:* As from 20 June 2016 until 1 July 2016, on randomly selected days and times, winners will be randomly selected by lucky draw from all Entries received thus far and will be notified and announced during Freshat5, which airs from 05h00 to 08h00, Hamman Time, which airs from 08h00 to 10h00, The Thando Thabooty Show, which airs from 10h00 to 13h00, The Forbes & Fix Show, which airs from 13h00 to 16h00 and/or The Roger Goode Show, which airs from 16h00 to 19h00. These winners will each receive five tickets to the “UNITE: The Mirror to Tomorrowland” event taking place on 23 July, 2016 at Nasrec Expo Centre, Johannesburg (each a “Local Ticket”). Note that Winners of Local Tickets during Phase 1 will not be excluded from the chance to play for one of the main prizes in Phase 2.

- ii. *Phase Two:* During Phase 2 (on 24 June and 1 July 2016), a total of 4 all-expenses-paid trips and tickets to the Tomorrowland event in Belgium (the “Main Event”) will be given away (each being a “Main Prize” as more accurately described below). Two randomly selected Entrants from the pool of Entries thusfar, will be contacted and taken to air on Freshat5, on Friday 17 June 2016 and again on The Roger Goode Show on Friday, 24 June, to play ‘Steal or Share’ for the chance to win one or two Main Prizes. The Steal or Share game will be conducted live on-air and ask each of the two randomly selected contestants to decide whether to ‘share’ or ‘steal’ the Main Prizes. If one contestant chooses to share and the other contestant chooses to steal, the contestant who chose to steal will win both Main Prizes. Should both contestants choose to share, each will win one Main Prize. Should both contestants choose to steal, then neither contestant will win a Main Prize and they instead each get two Local Tickets. The two Main Prizes so forfeited will be carried over to the next competition moment on either Freshat5 or The Roger Goode Show until all 4 Phase 2 Main Prizes have been won, subject to Phase 3.
- iii. *Phase Three:* During the final ‘steal or share’ game of Phase 2, it will be announced that there is a further 5<sup>th</sup> Main Prize and that this will be tentatively won by the contestant who had just lost the final Phase 2 ‘Steal or Share’ game (“Tentative Winner”), subject to potential challenges presented to him/her over the next 3 days. For the next 3 days, 5FM could phone the Tentative Winner at any time with a challenger who wants to steal his/her Main Prize. Such challenger will also be randomly selected from the pool of Entrants and the challenge to steal the Prize will take the form of a music quiz (with 3 questions). At the end of Phase 3 (Wednesday, 6 July 2016) the winner of the quiz will win the 5<sup>th</sup> and final Main Prize.
- e. **Main Prize description:** Each Main Prize is valued at R50 000 and includes the following:
  - i. Main Event Regular Full Madness Package – i.e. Regular Access to Tomorrowland Main Site on the Friday, Saturday and Sunday
  - ii. 1 x International Return Economy Flight ( JHB – FRA – BRU)
  - iii. 1 x Local return Economy Flight (should the relevant Main Prize winner be outside of Gauteng)
  - iv. Airport Transfers in Belgium to and from Dreamville at the Main Event

- v. Dreamville Accommodation – 4 nights (One man tent will be provided, winner needs to bring along sleeping bag, bedding or mattress if possible)
- vi. Daily S & T of 40 Euros
- vii. Cost of Schengen Visa Application
- viii. Travel Insurance
- ix. Goodie Bag upon arrival.

The Main Prize excludes road travel to and from the South African airport of departure/arrival and anything not described in the prize description above.

- f. **Requirements for winners:** To be able to receive the Main Prize, winners (and their selected travel partner, if applicable) will be required to be in possession of a passport valid until end January 2017 and must be available to travel between 21 and 25 July 2016, both dates inclusive. Winners of any of the prizes may be required to provide 5fm with additional information as may be reasonably required in order to verify the winner's eligibility and to process and/or facilitate the winner's acceptance and/or use of the prize. Should a winner fail to accept delivery of his/her prize, that winner will forfeit his/her prize and 5fm reserves the right to award such prize to another eligible Entrant chosen in the same manner as the original winner was. Proof of identity may be required to receive a prize and 5fm reserves the right to refuse handing over a prize to a potential winner who refuses to, or cannot provide sufficient documentation to verify his/her identity.
