

## 5FM General Ts and Cs

- All 5FM competitions are conducted in accordance with the provisions of Section 54 (1) of the Lotteries Amendment Act (46 of 2001).
- 5FM competitions are open to all South Africans, unless otherwise stated.  
Competitions are not open to employees, agencies, prize sponsors or contractors of 5FM, the SABC or any person directly or indirectly involved in the organisation or running of the competition, or their immediate family members.
- No person may enter the same or any other competition hosted partly or in whole by 5FM within three (3) months of winning the same or any other competition hosted partly or in whole by 5FM.
- The judges' decision is final and no correspondence will be entered into.
- Prizes other than cash are not transferable, cannot be deferred or exchanged for cash and are not negotiable.
- Winners use and accept prizes at their own risk. 5FM, the SABC and the prize sponsors (and/or their respective agencies) cannot be held responsible for any accident, injury, or loss of property experienced as a result of winning, accepting and/or utilising prizes won.
- Prizes not collected/claimed within 6 months of being won will be disposed of at 5FM's discretion.
- By entering 5FM competitions, entrants agree to adhere to competition rules and regulations, details of which entrants declare themselves conversant with.
- Any violation or attempt to violate any of the above rules will result in the immediate disqualification of the transgressor.

- 5FM may disqualify a transgressor for entry into any other 5FM competitions, for a period deemed appropriate by 5FM Management.
- 5FM and the prize sponsors reserve the right to cancel the competition at any time, if deemed necessary in their opinion, and if circumstances arise outside of their control and shall not be liable in anyway whatsoever to entrants in such event for any cause or action whatsoever.
- Winners may be required to have their details disclosed and appear on radio, television, the Internet or in printed publications.
- 5FM reserves the right to alter rules or prizes at their own discretion. Such altered rules and prizes shall become effective immediately after being altered or on such date as may be determined by 5FM. No entrant shall have any recourse against 5FM as a result of the alterations of the rules or prizes.
- 5FM will make every reasonable effort to deliver the prize described in the promotion's publicity, but cannot accept responsibility if the prize differs in whole or part from that advertised. Similarly, prize values quoted may differ from the actual value of the prize.

1. In addition to the 5FM Competition Terms and Conditions, the below conditions also applies for 5FM'S Easter Egg Hunt App competition for April 2022

#### 1.1 5FM Easter Egg Hunt App competition

- I. The competition will run from 04 April 2022 – 15 April 2022 (weekdays)
  - I. One (1) App winner to be made per weekday (Monday- Friday) during 04-15 April 2022 only.
  - II. To participate on the 5FM App, listeners need to download the official 5FM app available on Google Play and Apple App stores only.
  - III. The App user will need to find the hidden Easter Egg hidden on one of the 5FM pages on the App. This could be anywhere on the app, and the egg can be in the form of an image or text
  - IV. When the App user finds the hidden Easter egg, the user needs to click on a link which will lead them to the entry form that they would need to fully populate.
  - V. Winners will be selected at random.
  - VI. Winners will be announced on air
  - VII. Winners will be contacted by 5FM'S competition department directly.
  - VIII. One (1) winner per weekday (Monday to Friday).
  - IX. Total of 10 (ten) 5FM App winners only at the end of the Easter Egg Hunt App competition.
- 2 The prize of the 5FM Easter Egg Hunt App competition is R2 500 per winner (two thousand and five hundred rands) only.
  - 3 The prize is cash only.
  - 4 All entrants must be 18 years and older to enter.
  - 5 Judges decision is final and no correspondence will be entered into.
  - 6 Winners will be contacted by 5FM via email.
  - 7 By entering this competition, you voluntarily submit your personal details to 5FM (SABC) as per competition entry form. By entering, you consent for 5FM to collect and process this data as required for the competition. For more information, please consult 5FM's privacy policy on the 5FM website or App

- 8 Entrants enter this competition of their own free will. By entering, all entrants confirm that they have the legal capacity to enter the competition.
- 9 The 10 (ten) 5FM App winners is final and no reasons will be provided for such decisions. All entrants agree to not challenge or appeal such decisions.
- 10 App user may enter as many times as they please during the duration of the competition although only one (1) entry will be granted for the daily draw.
- 11 A person may only win once for either the on-air or on the 5FM app Easter Egg Hunt competition
- 12 A winner for the 5FM Easter Egg Hunt competition cannot win on both on air and 5FM app platforms.
- 13 If a winner is found to have won on both, 5FM reserves the right to disqualify the winner immediately.
- 14 5FM will contact all winners directly to populate the necessary SABC prize documents.
- 15 All winners will need to submit the required documents: Proof of residence and copy of ID.
- 16 Should winner utilize a bank account that is not under their name, they will be required to send an affidavit by both the owner of the account and winner, to grant permission for the SABC to transfer the money into owner of the bank account.
- 17 All entrants agree not to engage in any activities that violate any law, offend against public morals or embarrass 5FM or the SABC in any way.
- 18 By entering the competition, all entrants confirm that they are able to enter the competition and have no conflicting legal obligations.
- 19 Should the entrant breach any of these terms, 5FM may disqualify the entrant at any stage of the programme, without compensation, as an entrant, contestant, or winner of the competition.
