

COMPETITION RULES

This 5Drive Southern Africa Tour With Eye Gene promotional competition ("Competition") is run by Pharmacare Ltd t/a Aspen Pharmacare ("Promoter") and is open to all entrants of 18 years or older and resident in South Africa, except the employees and their immediate families of the Promoter, its advertising and promotion agencies, associated companies, and outlet owners and staff.

The Promoter reserves the right, at its reasonable and sole discretion and election, to alter, amend and/or cancel this Competition (including, but not limited to, the mechanics, value and/or prize) in its entirety. In the event of an amendment, alteration and/or cancellation, the Promoter will not compensate any individual for any reason whatsoever. These Rules and any amendments, alterations or cancellations will be at the instance of, and interpreted by, the Promoter only.

1. Only private persons may enter the Competition, that being any individual who is a citizen or national of South Africa.
2. Proof of South African citizenship and age may need to be presented by way of either a valid South African identity document or valid driver's license. This may be requested to be provided electronically via email.

Participation by all entrants ("Participants") constitutes acceptance of these Competition Rules ("Rules").

3. **Competition Period:** The Competition begins on 6 June and ends on 18 June 2021.
4. **Prize/s:** There will be 15 Prizes of R1000.00 (one thousand rand) each. Each prize to be won daily during the Competition Period.
5. Only 1 prize will be awarded per winner and no person may win more than once in this Competition.

6. **Entry (and cost if any):** To ensure a valid entry, Participants must go to the Eye Gene or 5FM Instagram and Facebook accounts to look out for a clue that will indicate an attraction in Southern Africa. The clue will consist of a blurred image from which participants must try to decipher the correct attraction. The attraction will be revealed, and a new clue posted, each hour commencing at 3pm and ending at 6pm each day during the Competition Period to guess the location and the image will clear up each hour to eventually reveal the location. To be entered into the Competition Entrants must share their answers using the hashtag #EyeGeneAfricaTour to 5FM's WhatsApp number: 082 550 5151 for a chance to win R1000.00 (one thousand rand).

7. **Draw and draw date/s:** The prize winners ("Winners") will be selected by random draw which will take place daily for the duration of the competition.

Winner/s Notification

A random winner, with the correct answer in the responding WhatsApp message, will be selected and called live on air in the last hour of the show between 5 and 6pm to give their answer. Should the Participant not answer the call, the presenter will move on to the next randomly selected Participant who submitted the correct answer.
