



Competition Terms and Conditions:

Addendum: Find Your Magic Competition

In addition to the standard 5FM Competition Terms and Conditions, the below conditions also apply for the Find Your Magic competition conducted on behalf of Axe (the promoter) on 5FM.

- a. The promoter is Unilever South Africa (Pty) Ltd (“the Promoter”).
- b. The competition is open to all South African residents who are 18 years old or older and in possession of a valid SA passport (having 2 blank facing pages with expiry dates not less than May 2018).
- c. This competition runs on 5FM from 28 August 2017 – 01 September 2017, on The Thabooty Drive, which airs from 15h00 to 18h00.

ENTRY REQUIREMENTS

- d. To participate, contestants must call the station (089 11 00 505) with the phrase “Axe – find your magic” as soon as the Black Coffee track plays.
- e. One finalist will be announced every day from Monday to Friday and entered into the grand prize draw for the trip to Ibiza.
- f. The grand prize draw will take place on Friday, 01 September 2017 on The Thabooty Drive and the winner will be announced on-air.
- g. The grand prize is an experience for the winner and friend to Ibiza to see Black Coffee play live.
- h. If a winner cannot be successfully contacted, is eligible to accept the prize, or contravenes the terms and conditions of this competition or of 5FM and the Promoter, the prize will be forfeit and another winner selected.
- i. Prizes are not exchangeable for cash or transferable.
- j. The winner, along with their respective companions, will need to apply for a Schengen visa for Spain through the Spanish Embassy in Pretoria. This is done by lodging the application online then making a personal trip to be interviewed at their Embassy, with their visa documents in hand. Scanned copies of the online application and visa documents need to be provided to the organizing Travel Agent (Sure Voyager Travel) prior to submitting online. The trip will be arranged by the competition organisers and their agents including travel costs to the Embassy on Monday, 4 September 2017. Should the Winner not qualify for a visa, the prize will be forfeited and the runner up will be chosen. Should the selected companion not qualify for a visa, the winner has the option to forfeit the entire prize or continue with the prize, travelling on their own.
- k. The Winner and their selected companion will only be allowed to travel to Ibiza with the group and must leave with the group on their return to South Africa. No extension of travel arrangements will be permitted, nor permission to travel ahead of the group allowed.

- l. The Winner and their companion undertake to join in all the activities planned for the group.
- m. The Winner and the companion confirm that they are fit and well enough to complete this journey and participate in all the activities planned for the group. The Winner and the companion further confirm that all medical and / or other conditions that he/she suffers from, will be disclosed. Failure to do this will result in the Winner forfeiting the prize. (This is vital so we know what special medical insurance the winner might require)
- n. By entering the competition, the prospective Winner accepts the Terms and Conditions of the competition as well as agrees to adhere to the Code of Conduct binding all Winners to the sponsor.
- o. Winners will be contacted via email.

PRIZE DETAILS

- p. The grand prize includes:
 - i. Return Local flight to closest international airport and Economy class flights from a South African International airport to Ibiza on fixed dates on a group basis.
 - ii. transfers from the Ibiza airport to the hotel on arrival and back to the airport on the day of departure;
 - iii. 3 night stay in a standard twin bedded room at a four star hotel selected by the Promoter; and
 - iv. EU60 spending money daily which is to be used for all meals, entertainment as well as money to cover entry fees not included in the prize.
- q. Hotels, flights and tours are subject to availability at time of booking. The Itinerary is subject to change by the Organisers and the Promoters and their Agents as may be necessary.
- r. If the Winner is not in possession of a valid passport, with at least 2 blank facing pages and being valid until May 2018, the Prize will be forfeited and another Winner may be selected in accordance with the above rules. The selected companion is required to have a valid passport, with at least 2 blank facing pages and being valid until May 2018.
- s. Unilever will set up the appointment for the Visa and arrange the travel required. The Winner and their selected companion bears all risks associated with any refusal of entry into Ibiza. No compensation will be payable if a Winner or companion is unable to use the prize (or any part of it) as stated for whatever reason. Proof of visa must be sent to the Promoter's agent.

Any additional expenses outside of the prize will be for the Winners own expense, and anything, including but not limited to any meal, activity, transportation, additional excursions, accommodation and all other costs and arrangements which are not included in the itinerary will be for the Winner's expense.

GENERAL

- x. Failure to claim the Prize or a refusal or inability to provide the required documentation, within the specified deadline, or comply with any of the competition requirements will disqualify the Winner and a new Winner will be drawn in terms of these rules.

- ff. In the event that the Prize is not available despite the Promoter's reasonable endeavours to procure the Prize, 5FM and the Promoter reserves the right to substitute the Prize of equal value.

Neither 5FM nor the Promoter, its agents, its associated companies, nor any directors, officers or employees of such, shall be liable for any loss or damage, whether direct, indirect, consequential or otherwise arising from any cause whatsoever, which may be suffered by the participant or the Winner.
