



Competition Terms and Conditions:

Addendum: Centbee

1. In addition to 5FM's standard Competition Terms and Conditions, the below conditions also apply Centbee competition conducted on behalf of Centbee.com (the promoter) on 5FM.
 - a. The competition takes place on air from the 23rd of September 2019 until the 27th of September on the following shows:
 - i. Monday 23rd September: The Roger Goode Show (07h00 – 08h00)
 - ii. Tuesday 24th September: Hamman Time (10h00 – 12h00)
 - iii. Wednesday 25th September: The Forbes and Fix Show (13h00 – 16h00)
 - iv. Thursday 26th September: The Thabooty Drive (17h00 – 18h00)
 - v. Friday 27th September: The Kyle Cassim Show (19h00 – 22h00)
 - vi. An additional chance to win exists on twitter.com/5fm if an entrant screenshots their wallet QR code and tweets it with the hashtag #Centbee5FM – this will take place during the 5FM Top 40 with Msizi James on Saturday 28 September between 10h00 and 14h00. Twitter entries will be valid from Monday 23 September until 12h00 on Saturday 28 September.
 - b. To participate in the competition, entrants are required to download and install the Centbee app. Centbee will receive all phone numbers of people who downloaded the app, as part of the user registration process. Centbee will provide 5fm with the 3 finalists' numbers and 1 winner will be chosen at random by the DJ.
 - c. Judges' decision is final and no correspondence will be entered into.

Please read these competition rules carefully. They explain your legal rights and duties about this competition. They form a legal agreement between you and Centbee ("the promoter").

Note: If you take part in this competition, or accept any prize, you agree that these rules will automatically apply to you and that Centbee can assume that you have read, understood, and agreed to be legally bound by these rules. The Terms of Sale of Bitcoin SV and Terms of Use will also apply to you. These rules apply in addition to 5FM's competition rules and Twitters Rules if you choose to tweet the hashtag #Centbee5FM. If you fail to comply with any of these rules, you will be disqualified.

1. THE PROMOTER

The promoter of this competition is Centbee (Pty) Ltd, with Registration Number: 2017/014560/07 ("Centbee"). In these rules we refer to Centbee as the promoter. We refer to participants and winners as "you". This competition will be hosted on 5FM, which is part of the South African Broadcasting Corporation (SABC). In these terms & conditions we will refer to the SABC as 5FM.

2. HOW THE COMPETITION WORKS

To qualify for entry into this Win R 5000 a day in Bitcoin SV on 5FM competition you must be a natural person with a valid RSA ID and need to do the following between the 18th and 28th of September ("the competition period"):

1. Download the Centbee app from the App Store or Play Store.
2. Install the app onto your mobile phone.
3. Register as a user on the Centbee app and be registered as KYC level 1 under Centbee's AML Policy.

NOTE: The following persons may not take part in the competition, even if they are eligible, and will be disqualified. They will forfeit (give up) or refund any prizes awarded to them. Employees, agencies, of Centbee or 5FM, the SABC or any person directly or indirectly involved in the organisation or running of the competition, or their immediate family members.

Before each of the 5FM shows specified below a name will be selected by random draw from all eligible entries by the Promoter. The Terms of Use (available on www.centbee.com) will also apply to you and your use of the prize. For purposes of these rules, Bitcoin SV will mean the cryptocurrency known as Bitcoin Satoshi Vision, Bitcoin SV, or BSV, all of which are interchangeable terms, and shall be valued at the most recently traded open market price as published in the Centbee app. Important note: Bitcoin SV is not the same as Bitcoin Core (BTC) or Bitcoin Cash (BCH). Bitcoin SV is not currently regarded as a financial instrument, and is not regulated in South Africa. Centbee is not a registered Financial Services Provider and is not providing investment advice to you. You agree that the promoter is not responsible for fluctuations in the value of the Prize. As the value of Bitcoin SV is not centrally controlled or fixed, you understand that it may fluctuate according to supply and demand or any other market factors which influence price. The prize will only be paid in Bitcoin SV at the prevailing exchange rate at the time the Bitcoin SV is sent to the winner's Centbee wallet. No cash or other payments will be made. - The promoter shall not be liable to you for any disruption to the competition, because of technical or other problems, which is beyond its reasonable control. If there is disruption to the competition the promoter will, where possible, take reasonable steps to fix any disruption and resume the competition on a fair and equitable basis to the entrants.

You must not assume that this means that the rules have been changed or that it no longer applies to you.
