



Competition Terms and Conditions: **Addendum: Thrive with 5 Competition**

In addition to the standard 5FM Competition Terms and Conditions, the below conditions also apply for the “Thrive with 5 Competition”.

- a. The promoter is Easy Equities (“the Promoter”).
- b. The Thrive with 5 Competition takes place from Monday, 24 September 2018 until Friday, 5 October 2018 on The Forbes & Fix Show, which airs weekdays from 12h00 to 15h00.
- c. Participation in the Thrive with 5 Competition constitutes acceptance of the Thrive with 5 Competition rules and participants agree to abide by the rules.

ENTRY REQUIREMENTS

- d. To participate in the competition, contestants must call 5FM when prompted to do so and correctly identify the applicable Easy Equities Thrive50 (as defined in Thrive Zero Brokerage Benefit Statement) stock for the day.
- e. Clues will be given on The Forbes & Fix Show and on 5FM and Easy Equities’ social media pages.

PRIZE DETAILS

- f. The daily prize is R2 500 invested into the Thrive50 stock identified on the day through the winner’s Rand denominated EasyEquities account. In the event that the day’s Thrive50 stock is US stock, the winner will receive R2500 into their EasyEquities Rand denominated account and the Promoter will assist the winner in transferring the prize into an EasyEquities US Dollar denominated account to be invested in the stock in question.
