



## **Competition Terms and Conditions:**

### **Addendum: Satrix The Most Thoughtful Gift**

### **Competition**

1. In addition to the standard 5FM Competition Terms and Conditions, the below conditions also apply for the Satrix The Most Thoughtful Gift competition conducted on behalf of Satrix (the promoter) on 5FM.
  - a. The competition takes place on The Forbes & Fix Show, which airs from 13h00 to 16h00, from 21 November to 25 November 2016.
  - b. To participate in the competition, contestants must call the show and share a story about the most awkward gift that they have ever received. The competition is only open permanent South African residents who are above 18 years of age. Employees of Satrix Managers (RF) Proprietary Limited or any of its affiliates or a supplier of goods and services in connection with the competition, their spouse / life partner or immediate family members, may not enter the competition.
  - c. The Forbes & Fix Show and/or show producer/s will judge the most creative entry of the day and award the winner with a R5 000 SatrixNOW investment voucher.
  - d. Judges decision is final and no correspondence will be entered into.
  - e. The promoter is Satrix Managers (RF) (Pty) Ltd, a registered and approved manager in collective investment schemes in securities and an authorised financial services provider.
  - f. The SatrixNOW investment voucher allows winners to invest in Satrix ETFs. Satrix is the manager of the Satrix Unit Trust Scheme and the Satrix Collective Investment Scheme in Securities where the ETFs are listed on the Johannesburg Stock Exchange (JSE). For both Unit Trusts and ETFs the investor essentially owns a “proportionate share” (in proportion to the participatory interest held in the fund) of the underlying investments held by the fund. With Unit Trusts, the investor holds participatory units issued by the fund while in the case of an ETF, the participatory interest, while issued by the fund, comprises a listed security traded on the stock exchange. ETF securities can be traded by any stockbroker on the stock exchange or via Investment Plans and online trading platforms. ETFs are index tracking funds, registered as a Collective Investment. ETFs may incur additional costs due to it being listed on the JSE.
  - g. Terms and conditions as set out on the SatrixNOW voucher apply. The voucher can be redeemed by the winner by opening an account on the SatrixNOW website and following the instructions to redeem a voucher. The winner must accept the usage terms of such an account and comply with the requirements for opening such an account, which include providing Satrix with information required by

law, e.g. FICA.
