# Complying with National Treasury's Central Supplier Database for Government

The National Treasury decided to establish and administer the Central Supplier Database on behalf of all Departments, Constitutional institutions and Public entities. The CSD serves as one single source of supplier information to all spheres of government.

HOW DOES THE CSD FORM PART OF THE OVERALL SUPPLY CHAIN MANAGEMENT



The CSD will be the single source of key supplier information for the whole of government. The CSD is a precursor (a building block) to the IFMS and e-Procurement systems — providing consolidated, accurate, up-to-date, complete and vetted supplier information.

It will enable future business intelligence (BI) reporting (spend analysis, SMME targeting for empowerment and growth, etc.) across spheres of government through the utilisation of a single supplier number and standard commodity codes.

FROM THE 1st JUNE 2016 (municipalities)\* / 1st APRIL 2016 (all other spheres of government) ALL SUPPLIERS GOVERNMENT PROCURES FROM MUST BE REGISTERED AND VERIFIED ON THE CSD.

WHAT DO YOU NEED TO DO TO COMPLY

### Get information about the CSD

It is highly recommended that you obtain as much information about the CSD from the Office of the Chief Procurement Officer of National Treasury.



# Get your suppliers on the CSD

On the go-live date, you will only be able to procure from the suppliers that are registered and verified on the CSD. As such, it is critical to ensure that current suppliers utilised, get registered on the CSD. If you have an electronic supplier database, you need to migrate them to the CSD. If not, visit <a href="https://www.csdprocure.co.za">www.csdprocure.co.za</a> and load your suppliers for automatic migration to the CSD.





The current Supply Chain Management processes, procedures and systems need to be aligned to the CSD to ensure that only registered and verified CSD supplier are used. This includes appropriate controls, in terms of CSD verification, at the relevant stages of the processes. This is required as the verification in the CSD is real time and a supplier verified now, might not be verified later.
