

## **GOOD HOPE FM - COMPETITION T's & C's**

1. All **Good Hope FM** competitions are conducted in accordance with the provisions of Section 54 (1) of the Lotteries Amendment Act (46 of 2001).
2. **Good Hope FM** competitions are open to all South Africans, residing in South Africa over the age of 18, unless otherwise stated. Competitions are not open to employees, agencies, prize sponsors or contractors of **Good Hope FM**, the SABC or any person directly or indirectly involved in the organisation or running of the competition, or their immediate family members.
3. No person may enter the same or any other competition hosted partly or in whole by **Good Hope FM** within three (3) months (i.e., 90 days) of winning the same or any other competition hosted partly or in whole by **Good Hope FM**.
4. The judges' decision is final, and no correspondence will be entered into.
5. Prizes other than cash are not transferable, cannot be deferred or exchanged for cash and are not negotiable.
6. Winners use and accept prizes at their own risk. **Good Hope FM**, the SABC and the prize sponsors (and/or their respective agencies) cannot be held responsible for any accident, injury, or loss of property experienced as a result of winning, accepting and/or utilising prizes won.
7. Prizes not collected/claimed within 6 months of being won will be disposed of at **Good Hope FM's** discretion.
8. By entering **Good Hope FM** competitions, entrants agree to adhere to competition rules and regulations, details of which entrants declare themselves conversant with.
9. Any violation or attempt to violate any of the above rules will result in the immediate disqualification of the transgressor.
10. **Good Hope FM** may disqualify a transgressor for entry into any other **Good Hope FM** competitions, for a period deemed appropriate by **Good Hope FM** Management.

11. **Good Hope FM** and the prize sponsors reserve the right to cancel the competition at any time, if deemed necessary in their opinion, and if circumstances arise outside of their control and shall not be liable to entrants in such event for any cause or action whatsoever.
12. Winners may be required to have their details disclosed and appear on radio, television, the internet or in printed publications.
13. **Good Hope FM** reserves the right to alter rules or prizes at their own discretion. Such altered rules and prizes shall become effective immediately after being altered or on such date as may be determined by **Good Hope FM**. No entrant shall have any recourse against **Good Hope FM** as a result of the alterations of the rules or prizes.
14. **Good Hope FM** will make every reasonable effort to deliver the prize described in the promotion's publicity but cannot accept responsibility if the prize differs in whole or part from that advertised. Similarly, prize values quoted may differ from the actual value of the prize.

1. Who is the Good Hope FM Voice? Competition
  - 1.1. The competition will run from 25 to 29 July 2022 (Mon - Fri) where one (1) App winner is to be selected per show (between 06:00 and 18:00) per day during 25 to 29 July 2022 only.

1.2. To participate in the Who is the Good Hope FM Voice? Competition, listeners need to download the official Good Hope FM App available on Google Play and Apple App stores only.

1.3. Listeners will then tune in to Good Hope FM between 06:00 and 18:00 each day from 25 to 29 July 2022 to listen to the audio clip played of one of the Good Hope FM presenters singing. A different voice will be singing on each show.

1.4. Once the listener has heard and recognised the voice played on during a specific show, the listener/App user will then go to the competition section on the Good Hope FM App and needs to click on the link which will lead them to the entry form that they would need to fully populate.

1.7. Winners will be selected at random.

1.8. One (1) winner per show per day (4 shows between 06:00 and 18:00 per day from Monday to Friday).

1.9. Winners will be called live on air and announced on air.

1.10. Winners will be directly contacted by Good Hope FM competition department.

1.11. A total of twenty (20) Who is the Good Hope FM Voice? Competition winners selected by the end of the Who is the Good Hope FM Voice? Competition.

2. The prize of the Who is the Good Hope FM Voice? Competition per winner is R2 850 (two thousand eight hundred and fifty rands) only.
3. The prize is cash only.
4. All entrants must be 18 years or older to enter.
5. Judges' decision is final, and no correspondence will be entered into.
6. Winners will be contacted via e-mail by Good Hope FM.
7. By entering this competition, you voluntarily submit your personal details to Good Hope FM (SABC) as per the competition entry form. By entering, you consent to Good Hope FM collecting and processing this data as required for the competition. 8. Entrants enter this competition of their own free will. By entering, all entrants confirm that they have the legal capacity to enter the competition.

9. The twenty (20) Who is the Good Hope FM Voice? Competition winners selected is final, and no reasons will be provided for such decisions. All entrants agree to not challenge or appeal such decisions.
10. The App user may enter once only per show on the Good Hope FM App but may enter the Who is the Good Hope FM Voice? competition once per show for each show for the duration of the competition. A different entry for each show.
11. A person may only win once for Who is the Good Hope FM Voice? Competition.
12. Good Hope FM reserves the right to disqualify the winner immediately if found that they did not comply with all the terms and conditions listed.
13. Good Hope FM will contact all winners directly to populate the necessary SABC prize winner documents.
14. All winners will need to submit the required documents, Proof of bank account details and a copy of ID.
15. Should a winner utilize a bank account that is not in their name, they will be required to send an affidavit by both the owner of the account and the winner, to grant permission to the SABC to transfer money into the account of the owner of the bank account.
