

## **TERMS AND CONDITIONS**

By participating in the Thobela FM **60**<sup>th</sup> **Birthday Celebration Competition**, Each Participant in this Competition agrees to the following terms and conditions:

- 1. The Competition is open to South African Citizens who are 16 years age and older.
- 2. The Competition comprises of a Cash Giveaway category of R120 000.00 in total where 20 Winners from this category stand a chance to win R 6 000.00 each; and a Thobela FM Hamper Giveaway category, where 10 Winners from this category stand a chance to each win a Thobela FM Hamper to the value of R 1500.00.

For a Participant to be declared a Winner in any category of the Competition, a Participant would have answered 10 questions in the Cash Giveaway category of the Competition correctly or would have performed the special activity in the Thobela FM Hamper category satisfactorily, in the discretion of the Station.

- 14. In the event of any dispute regarding these Terms and Conditions and/or the results thereof and all other matters relating to the Competition, the decision of Thobela FM shall be final and no correspondence or discussions shall be entertained by Thobela FM.

Thobela FM nor any of its contractors and employees will therefore not be liable for the payment of any royalties or any fees for publishing, reproducing, transmitting and broadcasting the voice note during the competition submission. Each Winner therefore agrees to release, defend, and hold harmless the SABC in publishing, reproducing, transmitting and broadcasting their audio clip/voice clip or video in whole or in part, including, but not limited to paper, broadcast, videotape, or via electronic/online media, from any claim, damages, or liability arising from or related to the use of the audio clip/voice clip or video, by the Winners or any third party.

Thobela FM does not accept any responsibility for any damage, loss, liability injury or disappointment incurred or suffered by any Winner in connection with their participation in this Competition. Thobela FM further disclaims liability for any injury or damage to any Winner's or any other person's device relating to or resulting from participating in or downloading any material in connection with the Competition.
