Ngekhava yempilo ye 1Life funeral, wena nabathandiweyo bakho ningabungaza impilo yenu namhlanje ngokuzibeka ethubeni lokuwina ingxenywe ka R24 000.

Ukungenela, lalela Ukhozi FM kusukela mhlaka **16 kuya ku 20 October 2017** bese u-SMSa igama lakho no "1Life funeral" ku 33126 noma ungenele on line@ukhozifm.co.za. Uma sibambe ucingo lwakho lapha emoyeni, phendula uthi "Changing Lives" ukuze uwine. Kuzoba nemiklomelo yansuku-zonke ka R3 000 ngo Msombuluko kuya ku Lwesine kanye Nomklomelo Omkhulu ka R12 000 ngo Lwesihlanu zingu **20 October 2017**.

### **Kungani kufanele ukhethe i-1Life funeral?**

- Ungazikhethela ukuthola ikhava esukela ku R5 000 ukuya ku R100 000.
- Uma ufake i-claim yagunyazwa ukhokhelwe emahoreni angu 24 (uma ulethe zonke izincwadi zoku claimer ezidingekayo)
- Ungafaka amalunga angaye afinyelele ku 16 engezelwe kwipholisi yakho.
- Ongakuthola okuyinzuzo nge Premium Waiver, (uma lowo oyimemba ephambili eshona, amanye amalunga ababhaliswe kuleyopholisi bazokhavwa kuze kuphele iminyaka emibili)
- Awuyukuhlolwa impilo uma uthatha lepholisi.

Akekho oyisisebenzi se 1Life Insurance Ltd ("inkampani") noma abanye abaxhumene nabo noma izinkampani/ ama ejensi, noma izisebenzi zawo noma imindeni yawo, noma amalunga axhase ngezimali abalulwe kulelikhasi lalomncintiswano, noma ezinye izinkampani ezihambisana nabo, izinkampani ezidlelana nabo ngandlela thile/noma ama ejensi kanye namalunga emindeni yabo, ngeke bakwazi ukungenela lomncintiswano ohlelwe abakwa 1Life Insurance Ltd.
2. Lomncintiswano uzoba khona phakathi komhlaka **16 kuya ku 20 October 2017**.
3. Umklomelo ozozuzwa ilabo abawinile uhlanganise u-R3 000 ongukheshi ngelanga kusukela ngo Msombuluko kuya ku Lwesine, kanye nomklomelo ngosuku lwamanqamu ongu R12 000 ngo Lwesihlanu mhlaka **20 October 2017**.
4. Abangenela umncintiswano kufanele bathumele i-SMS enegama labo no"1Life funeral" ku 33126 ukuze bakwazi ukufakwa kwi draw yalabo abazoba nenhlanhla kusukela ngo **Msombuluko mhlaka 16 kuze kube uLwesihlanu zingu 20 October 2017**.

5. Uma ucingo lwakho lubanjwe emoyeni bukhoma ukuze uwine umklomelo wansuku-zonke ka R3000 phendula uthi "Changing Lives" uzibeke ethubeni lokuwina u-R3 000 ngo Msombuluko kuya ku Lwesine.
6. Bonke abangenele bangawina emiklomelweni yansuku-zonke bazofakwa kwi lucky draw, ezoba ngo Lwesihlanu mhlaka (20 October 2017). Oyedwa owinile uzokhethwa ngalesosikhathi aziwinele u-R12 000.
7. Kuzoba nemiklomelo eyisihlanu yemali, emine kuyo kuzobe kungukheshi ka R3000 ngelanga kanye nowodwa umklomelo Omkhulu wemali ongu R12 000.

9. Abawinile bazokwaziswa ngocingo. Uma singakwazanga ukuxhumana nowinile emva kokuzama kuze kube kathathu, uma sekuvalwe umncintiswano, umklomelo uzodluliselwa komunye otonyulwe kabusha wawina.
10. Abawinile kuzobuye kuxhuyanwe nabo emoyeni uma sebazisiwe ngocingo.
11. Abantu abaneminyaka engaphansi kuka 18 abavumelekile ukungenela lomncintiswano.
12. Lomncintiswano uvuleleke kwizakhamuzi zase Ningizimu Africa kuphela. Kuzofanele uveze isiqinisekiso sokuba isakhamuzi, noma ulethe Umazisi wase Ningizimu Africa, noma i-licence yase Ningizimu Africa yokushayela noma i-Passport yase Ningizimu Africa.
13. Owinile kuzofanele avume ukuthi uzozibophezela emigomeni yenkampani ukuthi aziswe kunoma iziphi izikhangiso ezimayelana nalomncintiswano.
